### **Notification share buy-back**

*Sant'Agata Feltria (Rimini)*, 11 March 2020 – **Indel B S.p.A.** - company listed on the Borsa Italiana MTA, heading a group that operates in the production of cooling systems and air-conditioning for mobile and mobile living for the Automotive, Hospitality and Leisure Time markets (pleasure boats and recreational vehicles) – under the buyback program of treasury shares announced to the market on May 9, 2019, and launched on May 15, 2019 up to n. 100,000 ordinary shares, announces – according to the provision and for the purpose of Article 5 of Regulation (EU) 596/2014 and Article 2, paragraph 3, of the Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 – to have acquired on the Mercato Telematico Azionario (MTA) organized and managed by Borsa Italiana S.p.A., in the period from 5<sup>th</sup> March to 11<sup>th</sup> March 2020, total n. 2,730 of treasury shares (corresponding to 0.047% of the total number of ordinary shares), at a weight average price of Euro 15.3721 for a total counter-value of Euro 41,965.80.
