INDEL B JOINS FTSE RUSSEL INDICES

Inclusion in the FTSE Italia Indices is the result of the quarterly review carried out by the FTSE Italia Index Series Technical Committee and represents an important recognition of Indel B's industrial and financial soundness, as well as the company's growing visibility and attractiveness in the capital market.

The Company has a market cap of approximately Euro 113 million.
