Notification share buy-back

Sant'Agata Feltria (Rimini), 08 July 2026 – **Indel B S.p.A.** - a company listed on the Borsa Italiana EXM and parent of a group that operates in the manufacture of cooling systems and air-conditioning for mobile and mobile living for the automotive, hospitality and leisure time markets (pleasure boats and recreational vehicles) – under the buyback program of treasury shares approved by the Shareholders' Meeting on May 25, 2026 and initiated following the resolution of the Board of Directors on June 16, 2026 up to n. 100,000 ordinary shares - pursuant to Article 5 of Regulation (EU) 596/2014 and Article 2, paragraph 3, of the Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 – announces to have acquired on the on the Euronext Milan (EXM), organized and managed by Borsa Italiana S.p.A., in the period from 02nd July 2026 to 08th July 2026 both total n. 1,821 of treasury shares (corresponding to 0.031% of the total number of ordinary shares), at a weight average price of Euro 19.6762 for a total counter-value of Euro 35,830.40.

On the basis of information provided by Banca IMI, the authorized intermediary in charge of carrying out the buyback transactions described in this present press release, here below is a summary of the daily transactions, in aggregate form:

The company has a market cap of approximately Euro 115 million.
